MQA DELEGATED FUNCTIONS

- Review/align/develop Occupations Qualifications as delegated to MQA.

- Review/align/develop Assessment Tools for Occupations Qualifications.

- Conduct/Collaborate on accreditation audits for SDPs or ACs on Occupations Qualifications as registered on QQSF.

- Ensure quality learning delivery and Assessments process within MMS.

- QALA for historically registered qualifications including sector skills programmes

- Support for learner assessment, completions, verifications, validations and administration.

MQA MANDATORY FUNCTIONS

- Support review/align/advice on Learning Materials related to Occupations for MMS.

- Review/develop/align standard (moderation) and criteria for Assessment Centres

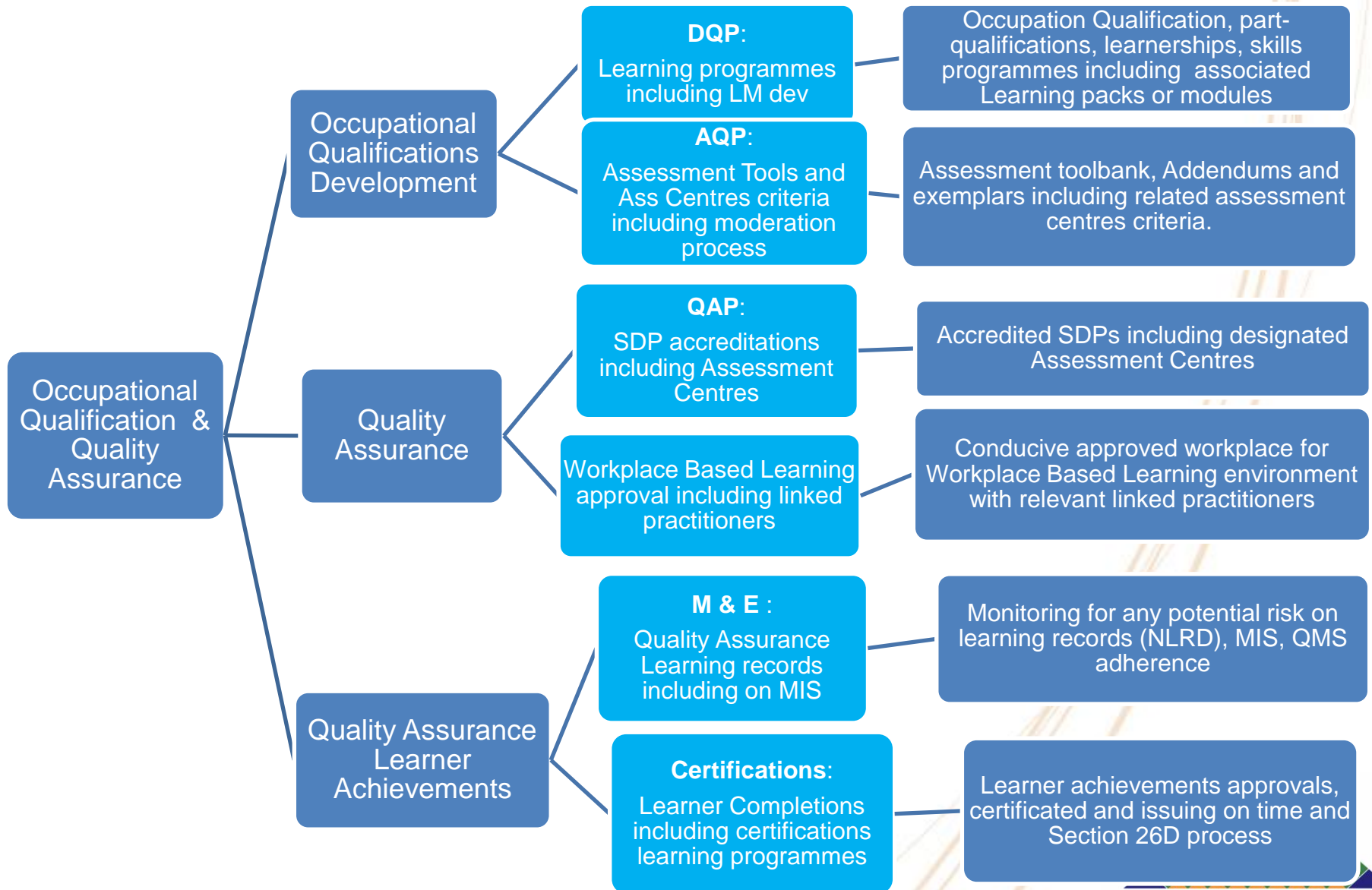
- Conduct audits/ identify conducive approved workplace for Workplace Based Learning with relevant practitioners.

- Advise on QA accreditations and standards for regulated qualifications included associated skills programmes for MMS.

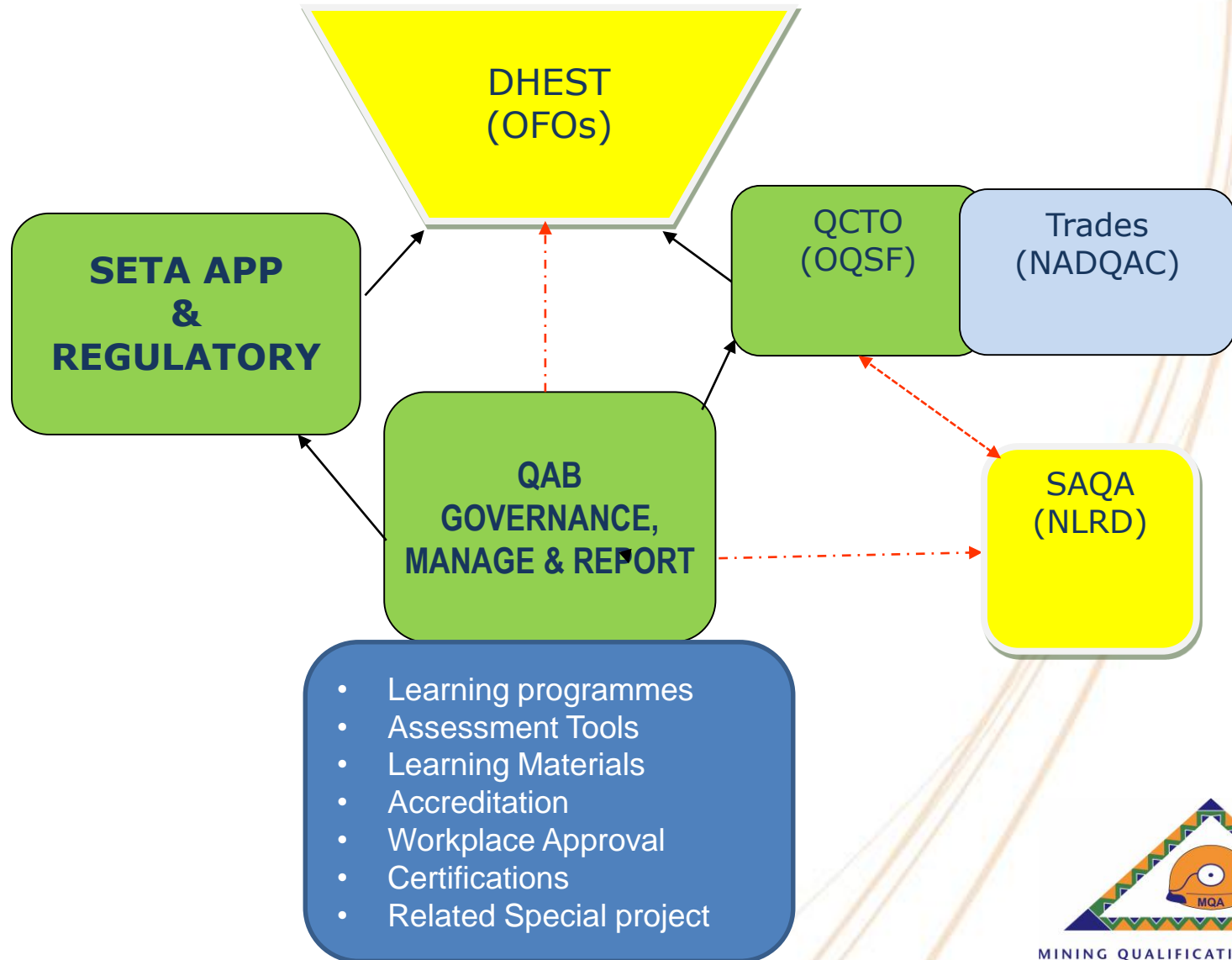
- Promote learning programmes by improving the facilitation of learning, Learner records Database (LRD), MIS, QMS adherence

- Learner achievements approvals, certificated and distribution (on time) including for Section 26D.

11 Steps for Quality Assurance on Accreditation and WPA Process

QCTO ROLES

1. Accreditation request – SDP submit request to QCTO for all qualifications by completing letter of intent.

2. Accreditation Referral letter – Only issued by QCTO to applicant for SETA accreditation process.

8. Ratification – QCTO ratify the audit report and communicate.

9. Letter of accreditation – QCTO issue accreditation letters for all qualifications to maximum of five (05) years.

10. SDP/QCTO – SDP/QCTO submit copy of accreditation letter to SETA.

SETA ROLES

3. Accreditation request – SDPs submit accreditation referral letter with the SETA application for all qualifications, whilst for **Skills Programmes** SDP apply direct to SETA including workplace approvals.

4. Acknowledgement Letter – Only issued to applicant for accreditation or workplace process.

5. Notification Letter – after evaluation process and intent for audit. All audit process done as per SETA specifics on accreditation or workplace approvals.

6. Audit Outcome – Audits reports and recommendation referred to QCTO for ratification; **ONLY** for Skills Programmes accreditation and or workplace approvals referred for SETA process.

7. Confirmation letter – SETA issue confirmation letter to applicant on recommended report to QCTO or linked scope/s on SETA MIS.

11. Access - MIS access shall only be upon submitted QCTO letter by SDP, only recorded scope delegated to SETA will be linked.

QUALIFICATION LIFE SPAN AND CERTIFICATION FORMAT

Qualifications re-registrations or de-registration process including related certification format or feature are subjected to:

- SAQA in writing, notify the QCTO of qualifications that are about to expire, and advise that the review be done and recommended the qualifications and part qualifications that must be re-registered or deregistered.
- However, Certificate format or feature review with the periodically reviewed qualification. Subsequently, the approved certificate template for MQA is in place.
