DETAILED SCOPE OF WORK

(i) Demolition and Removal

The appointed service provider shall:

- Carefully remove and dispose of three (3) existing toilets, including:
 - Toilet pans
 - Cisterns
 - Toilet seats
 - Associated plumbing fittings and connectors where required
- Ensure removal works are carried out carefully to avoid damage to:
 - Existing plumbing infrastructure
 - Wall finishes
 - Floor finishes
 - Surrounding fittings
- Remove all rubble and waste material from site and dispose of same at an approved disposal facility

ii) Supply and installation of toilets

The appointed service provider shall:

- Supply and install three (3) new close-coupled toilets (Close-Coupled TQF toilets-) complete with:
 - Toilet pan
 - Close-coupled cistern
 - Toilet seat and lid
 - Flush mechanism
 - All necessary plumbing fittings and connectors

The toilets must:

- Be suitable for office/high-traffic environments
- Be water-efficient
- Be SABS approved
- Be white ceramic finish
- Be installed level and aligned correctly
- Be fully operational and leak-free upon completion

The installation shall include:

- Connection to existing plumbing services
- Testing of flushing systems
- Sealing and finishing around installed units
- Cleaning after installation

iii) Supply and installation of a mirror

The appointed service provider shall:

- Supply and install one (1) wall-mounted bathroom mirror- rectangular/circle mirror with black slimline frames_500 × 1200

The mirror must:

- Be modern and suitable for office bathroom use
- Be securely mounted
- Include all mounting accessories and fittings

2. GENERAL CONDITIONS

- The appointed service provider must submit a Safety File before commencement of work.
- All materials and fittings supplied must be SABS approved.
- The quotation must include all labour, materials, consumables, fittings and equipment required to complete the works.
- The contractor must ensure minimal disruption to office operations.
- The contractor must maintain cleanliness and safe working conditions at all times.
- All plumbing works must comply with applicable plumbing standards and regulations.

3. MANDATORY REQUIREMENTS

-The prospective service provider must be registered with CIDB, class of work: 1SO or higher (Water supply and drainage for buildings - wet services, plumbing) class of works.

-Provide a minimum of two (2) reference letters/completion letters from previous clients for related work. For the reference letter/completion letter to comply it must be on the client's letterhead, signed, work done within 3 (three) years prior to closing date of this request, and explaining or narrating the services provided: Sanitaryware installations and plumbing works/Plumbing maintenance or installations.

NB: The MQA reserves the right to verify the information provided, including conducting site visits at any of the referenced clients' premises where similar work was undertaken. Should the service provider fail to facilitate such verification, or should the site visit or client feedback not confirm the work and scope as stated in the reference letter, the submission may be deemed non-responsive or non-compliant.
